Sub : Post Matric Scholarship to SC/OBC students.

It is hereby informed to all the heads of the educational institutions that applications of SC/OBC students pertaining to the above scheme shall be obtained at the time of admission to the concerned stream. A list of fresh/Renewal students accompanied with duly filled application form for fresh & Renewal and requisite documents (Caste certificate, Income certificate, Fee Receipt, Passing/mark sheet, Aadhar card, Bank Account details (Xerox copy of pass book showing details of student, G.A.R.33 duly signed by the Head of Department) shall be submitted to this Directorate along with the details of the students given in the enclosed proforma (Annexure "A") in **Hard copy** as well as **Soft copy**, compulsorily failing which applications will not be entertained. Hence forth the Applications should reach this Directorate on or before 30th September, 2019 positively duly completed in all respect and supported with all the documents prescribed under the scheme. Incomplete applications & without soft copy will not be entertained.

Family income ceiling will be as follows:

1. SC ----- Rs. 2.50 lakh per annum (valid for 3 years from the date of issue).
2. OBC ----- Rs. 1, 50,000/- per annum (valid for 3 years from the date of issue).
3. Kanya Dhan(for SC) ---Rs.1.20 lakhs per annum. Valid for 3 years from the date of issue (for the Higher secondary school).
4. Home Nursing Scholarship (for SC/OBC & General) --- Rs.1.50 lakhs per annum. (Valid for 3 years from the date of issue).
5. Caste certificate (for OBC community is valid for 3 years from the date of issue).

It may be ensured that application forms in case of fresh applications and the list of students in case of Renewal are scrupulously examined at the institution level before the same are submitted to this Directorate.

It is advisable that the Educational Institution nominates a Nodal Officer to create awareness of the scheme in the institution and to ensure that maximum students who are entitled to the benefit of the scheme apply to avail the scheme and for ensuring the submission of forms/documents specified within the given period.

The students applying under Post Matric Scholarship scheme should be instructed to open a saving Bank Account in any Nationalized Bank, as the amount of Scholarship will be directly credited to the Bank Account of the student.

The applications received first will be given first preference. The applications received after due date will not be binding on the State Government for sanctioning the same.

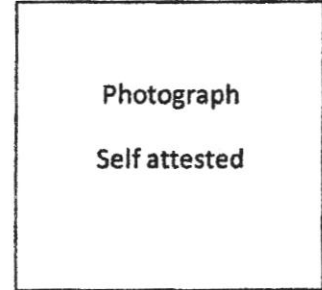
